In pursuance of BSNL CO New Delhi letter No 412-13/2013-Pers.I (I) & (II) dated 22/03/2013 the SDEs listed in the Annexure are hereby ordered to look after the current duties of Divisional Engineer, temporarily for a period not exceeding 179 days with effect from **26/04/2018** on the terms and conditions as detailed below:

The Looking after arrangement is made on local basis and this will not confer any right on them to continue in the post/grade. The arrangement is temporary and likely to be terminated without notice at any time. On termination of this arrangement the officers will be reverted to their regular posts from where they are promoted unless otherwise ordered in the mean while.

In case any vigilance/disciplinary case is pending/contemplated against any of the officer or any punishment like stoppage of increment is current, this looking after arrangement should not be given effect to and the fact should be intimated to this office immediately.

The service in the higher grade under this arrangement will not count for any benefit in matters of future promotion, seniority

The Executives manning higher posts in this manner may be given functional powers (Administrative and Financial) attached with the post. This will only be a stop gap arrangement till a regular arrangement is made. The looking after arrangement is made without any extra remuneration/fixation benefit.

The SDEs ordered to look after as DE stand reverted to their parent cadre on **20/10/2018** on completion of 179 days or a regular incumbent is posted whichever is earlier.

This is further subject to outcome of various Court cases pending in Hon'ble Courts/BSNL CO instructions and guidelines
