In pursuance of instructions contained in BSNL CO orders cited above the DEs listed in the Annexure are hereby ordered to look after the duties of DGM with immediate effect for a period of 89 days or a regular incumbent is posted whichever is earlier on the following terms and conditions:

- a) The DEs ordered to look after as DGM are not entitled for any extra remuneration
- b) The service in the higher grade under this arrangement will not count for any benefit in matters of future promotion, seniority
- c) The DEs ordered to look after as DGM shall exercise functional powers (Administrative and financial) attached to the post.
- d) The looking after arrangement is subject to the condition that there is no Vigilance/Disciplinary case pending against the officers or they are under currency of punishment.
- e) The DE ordered to look after as DGM shall stand reverted to their basic grade on completion of 89 days or a regular incumbent is posted whichever is earlier.

Necessary charge report shall be furnished to all concerned.
